

## Call for application „Georgius-Agricola-Scholarships 2024“

Announcement of partial scholarships of the Saxon State Ministry of Science, Culture and Tourism (SMWK) for the promotion of students from the countries of Central, Eastern and South-Eastern Europe (CEE) on the basis of the funding guideline Georgius Agricola Scholarships of 17.12.2004

### Purpose of Funding:

Funding is provided for study visits by foreign students of higher semesters and graduates from **the countries of Central, Eastern and Southeastern Europe** (according to the DAC List) with above-average performance and good to very good German language skills with the aim of acquiring young executives for business, politics and science. The study or research stay in Saxony should serve to further their professional qualification. Applications within the framework of academic cooperation agreements will be given preference.

Monthly funding amount: 450,00 Euro  
Funding period: in coordination with the receipt of the application documents  
Application deadline: **14.04.2024**

### Requirements:

- Enrolment at the Chemnitz University of Technology
- Above-average academic performance
- Good to very good German language skills
- Social engagement
- Financial need

CEE countries on the DAC list: Albania, Belarus, Bosnia and Herzegovina, Kosovo, Moldova, Montenegro, Northern Macedonia, Serbia, Turkey, Ukraine

### Funding regulations:

The applicant undertakes in writing to comply with the study and examination regulations of Chemnitz University of Technology. Secondary income will be credited against the scholarship if the total amount exceeds 350.00 Euro per month. There is no legal claim to the granting of a scholarship. The award is made by the IUZ Scholarship Commission and subject to the provision of funds by the SMWK. If there is a sufficient number of eligible initial applications, the IUZ Scholarship Committee reserves the right, depending on the availability of funds at the time, to give priority to any renewed applications from applicants who have already received funding.

Another requirement for the scholarship is the signing of a so-called return commitment, i.e. the scholarship holder undertakes to return to his/her country of origin after completing his/her studies (except students from Ukraine).

**The following documents must be submitted:**

- Fully completed and personally signed application form "Application for a Partial Scholarship" including
  - Letter of motivation and
  - Letter of reference from a university lecturer at Chemnitz University of Technology and/or the home university
- Tabular CV
- List of previous academic achievements (current transcript of records, university certificate)
- Proof of German language skills
- Current certificate of enrolment from the TUC (or letter of admission)
- Copy of passport

PhD students must also submit:

- Confirmation of supervision by a university lecturer at TUC
- Details on the PhD project (2-3 pages)

**The following applies to all scholarship programmes:**

- I. The award is made by the IUZ Scholarship Commission. The criteria result from the above-mentioned requirements.
- II. Only study visits to the TU Chemnitz are funded.
- III. Scholarship holders are obliged to immediately inform the IUZ and the Studentenwerk Chemnitz-Zwickau of absences and additional income, for example from other scholarship programmes or employment.
- IV. There is no legal entitlement to the granting of a scholarship. Scholarships can only be awarded subject to release and depending on the amount of the grant by the SMWK after approval by the scholarship commission.
