The students register to their courses according to the learning agreements approved by IUE and the sending university. For Erasmus+ exchanges, IUE uses Online Learning Agreement (OLA) primarily.</p> <p>If there occurs any course overlaps or if any of the courses are not offered, students will be able to add and drop courses during the first two weeks of the semester.</p>
