

Subject: Chemnitz as a Science and Business Location

According to its own university development plan, Chemnitz University of Technology strives for "close cooperation with the central players in the region as well as the science and business location Chemnitz. These include, in addition to the two Fraunhofer Institutes, the city of Chemnitz, (vocational) colleges, companies, and cultural institutions in southwestern and central Saxony in particular. It aims to close ranks with these players in order to strengthen and (further) develop Chemnitz as a location for science and business."

Question 1: How will you support Chemnitz University of Technology in this endeavor as Mayor?

Question 2: How do you intend to strengthen and (further) develop Chemnitz as a location for science and business?

Topic: City Center Campus (Campus on Straße der Nationen)

According to its own university development plan, Chemnitz University of Technology "together with the city [...] is pursuing the long-term goals of developing the university location into a real city center campus and of bringing academic and student life closer to the city center and making it more visible".

Question 1: As Mayor, how will you contribute to developing the campus on Straße der Nationen into a "real city center campus"?

Question 2: Through which measures will you support the revitalization of the Brühl?

Topic: Cosmopolitan and Acceptance-Oriented Climate

The Academic Senate at Chemnitz University of Technology passed the following statement in its session on 28 May 2019 on the occasion of the Chemnitz city council elections. "As an educational and research institution, offers people from all over the world a home and welcomes them – regardless of where they come from, what religion they practice, their sexual orientation, or their choice of cohabitation."

Question: Can you fully and completely identify with this position?

Subject: Technology Campus South

On 6 January 2016 the development plan no. 09/06 "Technology Campus South" came into force (see Amtsblatt No. 01/16). As stated in draft resolution No. B-225/2018, one of the aims of the project was to provide development opportunities for Chemnitz University of Technology with the SOU6 construction area of approximately three hectares. However, on 14 August 2018, the Planning,

Construction and Environmental Committee of the City of Chemnitz approved the initiation of the procedure to amend the development plan for the aforementioned SO_U6 sub-area. The aim was - as stated in the draft resolution No. B-225/2018 - to change the "Purpose of the 'University' special area, construction field 6 (SO_U6) to the 'Technology Campus' special area, construction field 6 (SO_T6)" in order to be able to "locate technology-oriented companies there." "Furthermore, the Free State's very long-term development ideas for Chemnitz University of Technology (...) should, in due course, yield other prospects in the area near Reichenhainer Straße."

Question 1: What do you think about this approach and this objective?

Question 2: Will you make every effort to ensure that the building area SO_U6 remains exclusively reserved for building projects by Chemnitz University of Technology?

- **If yes: What will you do specifically to achieve this?**
- **If not: How should the legitimate and long-term interests of Chemnitz University of Technology be taken into account?**
